<u>Providing or subsidizing the costs of high-speed internet to students or faculty to transition to an</u> online environment:

CARES 18004(a)(1) Institutional Funds were used to purchase Verizon Hotspots that students can borrow to ensure reliable internet connection for the remote learning environment. Funds were also used for a Creative Cloud educational subscription for classroom use.

Campus safety and operations:

Funding was used from the CARES 18004(a)(1) Institutional Funds to ensure the safety of the campus for a hybrid learning environment. Prior to the resurgence of the COVID-19 virus, a hybrid learning model was used that allowed students to attend campus for certain laboratory classes. In order to provide a safe learning environment for students, faculty, and staff, the College purchased additional supplies of PPE, including masks, alcohol wipes, and hand sanitizer.

Following health guidelines, the College hired checkpoint screeners to be placed at the limited entrances to campus in order to take temperatures and ensure masks were worn by those entering buildings. Additional directional signs were placed to guide individuals to the limited entrances with the checkpoint screeners. The costs associated with payroll for the checkpoint screeners and the new directional signs were charged to the CARES 18004(a)(1) Institutional Funds. When there were confirmed or suspected cases of COVID-19 from individuals who had recently visited campus, deep cleaning was carried out in the relevant buildings. The costs of the cleaning and the additional Tyvex Coveralls provided to cleaning staff were charged to the CARES 18004(a)(1) Institutional Funds.

<u>Purchasing</u>, leasing, or renting additional instructional equipment and supplies (such as laboratory equipment or computers) to reduce the number of students sharing equipment or supplies during a single class period and to provide time for disinfection between uses:

The CARES 18004(a)(1) Institutional Funds were used to purchase portable medical simulation kits so students could continue participate in remote learning.

<u>Purchasing</u>, leasing, or renting additional equipment or software to enable distance learning, or upgrading campus wi-fi access or extending open networks to parking lots or public spaces, etc:

With the continued remote learning and working environment, the College had to further upgrade the firewall security for remote connection as well as increasing the server volume load.

The cost of this upgrade was covered by CARES 18004(a)(1) Institutional Funds. The College purchased additional laptops to be loaned to faculty or staff that didn't have reliable access to necessary equipment at home. Laptops purchased during the first quarter were rapidly lent out to staff and faculty as needed. Additional charges to CARES 18004(a)(1) Institutional Funds were for Cisco telephones (allowing student advising and financial aid services to continue at employees' homes) and Citrix software for remote access to College systems.

Other Uses of (a)(1) Institutional Portion funds:

The College has provided a stipend to faculty and staff each pay period to accommodate their need for increased internet speed as well as other utility costs incurred as a result of working from home. When campus returns to normal operations, the stipend will no longer be provided. The stipend is being offset with CARES 18004(a)(1) Institutional Funds.
