Bid security in the form of bid bond in an amount equal to 10 percent (10%) of the aggregate of the Base Bid amount and all Alternate Bid amounts shall be submitted with the bid. The successful bidder must furnish a satisfactory performance and payment bond in the full amount for their portion of the bid to M.A. Mortenson Company.

Contractors shall pay not less than the prevailing rates of wages to all laborers, workmen, and mechanics performing work under this contract, and shall comply with the requirements of the Illinois Wages of Employees on Public Works Act (820 ILCS 130/1-12)

Bidders shall comply with Business Enterprise Program: Participation and Utilization Plan developed by Harper College. There is a 20 percent aspirational goal on the contract.

Offers may not be withdrawn for a period of ninety (90) days after the closing date without the consent of the College.

Any bid submitted unsealed, unsigned, fax transmissions, emailed or received after the date and time, will be disqualified and returned to the Bidder.

The College reserves the right to accept or reject all bids or parts thereof, to waive any irregularities or informalities in bid procedures and to award the contract in a manner best serving the interest of the College.
