The meeting was called to order at 8:45 p.m. by President John A. Haas.

In the absence of the secretary, Mrs. Nicklas, a motion was made by Member Hansen, seconded by Member O'Dea, to elect Member Hamill secretary pro tem. The nominations were closed and a unanimous ballot was cast for Member Hamill to act as secretary pro tem.

On motion of Member O'Dea, seconded by Member Hamill, the bills, totalling \$1,467.91, were approved.
