## DISCUSSION OF FOLLOW UP ITEMS

Darlene Schlenbecker and Julie Ellefson provided the Board with an overview of the accreditation process in preparation for the Higher Learning Commission March visit and the November mock visit. They stated the Board would receive an electronic draft of the Assurance Argument by end of this week for their review.

Maria Coons presented an update on the President's Priorities. She reminded the Board that updates are included in the monthly President's Report.

Bret Bonnstetter reviewed the FY2013-2017 Operational Analysis Cost Comparison. This report will be reviewed annually as was requested at the July 2017 Board Workshop.

Bret Bonnstetter provided an update on the FY18 Budget/Actual-Tax Capped Funds.

Bret Bonnstetter reviewed the 2009A Referendum Bond Refunding process. He stated the refinancing timing is right to obtain competitive pricing. There is potential for taxpayer savings, with no cost or savings to the College. The call date for the bonds is December 18, 2017. He expects to present a resolution for sale approval at the November 15, 2017 Board meeting.
