<u>DISCUSSION OF</u> FOLLOW UP ITEMS Dr. Mark Mrozinski discussed the next steps for the Strategic Planning and Accountability Committee in evaluating Harper's guiding statements (Mission, Philosophy, and Vision). Mark provided background that the Committee provides college-wide oversight for the strategic plan; and that they are in year two of a four-year planning cycle.
