In the early 1980s, the Harper College Educational Foundation partnered with two local corporations to create scholarships to help engineering students. The Northrop Grumman Engineering Endowed Scholarship and the Square D 2+1 Endowed Engineering Scholarship are classified as "2+1" scholarships because they support Harper students during their two-year tenure and also during their first year at a transfer school. Since the inception of these scholarships, more than 20 students have received support and transferred to schools that included the University of Illinois, Northern Illinois University, Northwestern University and Iowa State University.

New Acquisition

The Educational Foundation has partnered with Harper College to purchase a six-foot bronze sculpture, *A Walk in the Mist*, for the atrium in Avanté. **Jim and Judy Dodson** of Arizona designed the sculpture that became a part of the Foundation's permanent art collection in August. A grant from the **Omron Foundation** helped to underwrite the purchase.

Small Works Exhibit Purchase Award

The Educational Foundation has purchased two works of art from the 2005 Small Works Exhibition. *Looking* by **Yvonne Petkus** is an oil-on-board piece that uses paint in an Impressionist-like technique of distinct dabs.

Floating Lizards by **Rich Lane** of Barrington is a 10.5 by 10.5 inch black and white photograph. Lane, a former Harper art student and fine arts photographer, has been teaching art at John Hersey High School in Arlington Heights for the last 11 years. "I strive to capture the beauty and mystery in bizarre, unusual subject matter." said Lane in an artist description.

These two pieces will join the Harper College Educational Foundation Art Collection, now valued at \$1.2 million.

Art Reception

The Foundation's Director's Circle hosted their second annual Small Works art reception for 150 people in April to kick off the 2005 exhibit. Harper art faculty, alumni, students and artists represented in the 28th annual show were treated to gourmet wine and cheeses, generously donated by **Chicago Prime Steakhouse**.

Guests participated in a raffle of a unique necklace that was designed by Harper fashion design student **Maria Fung**. Fung won a design contest and scholarship sponsored by **Wyatt Austin Jewelers**. Wyatt Austin took Fung's design and created a beautiful object of art made of hematite, sterling silver and Swarovski crystals. Raffle proceeds will benefit the art program at Harper. Other highlights of the evening included tours of the exhibit. "The reception was a wonderful event that brought together artists, donors, students, professors and our community. The exhibit display was notable for its diversity. I also think the exhibit challenged many of the attendees to expand their notions of art," said Martha Bell, who has served as a Foundation Board member for 14 years. "The Arts Committee was pleased the College was able to acquire several pieces to broaden our collection and its educational value."

According to **Perry Pollock**, assistant professor of art, the Harper show has evolved over time from a more traditional art show to a contemporary, well-balanced mix of various works.

Program Highlights

Bridging the Digital Divide

Harper College offers an Adult Education Development (AED) program at the Palatine Opportunity Center (POC) that is designed to help bridge the digital divide that exists between households with access to the Internet and households without access. While computer ownership and Internet access rates are rising annually nationwide, there are a large number of people in Harper's community who don't directly benefit from Internet access at home. The Harper College Educational Foundation provided funding to the AED program at the POC that helped purchase new computers for classes and training sessions.

Jennifer Bell, an adult education development instructor at Harper, thinks the AED department "has been making great progress in bridging the digital divide." The department now has 92 computers located at four locations; 24 are located at the POC.

"Our goal at the POC is to address the digital divide by improving our students' literacy and technology skills," Bell said. Courses taught by Bell include basic Internet, Web search, e-mail, keyboarding and word processing skills. Through courses like these "students who once could not use a mouse are now reading about medical illnesses online, finding information on how to get a driver's licenses and typing letters to their land-lords to request services."

Distinguished Scholar Award

In keeping with the Harper College emphasis on academic excellence, Harper College offers the Distinguished Scholar Award to students who rank in the top 10 percent of in-district high school graduating classes. These students are eligible to receive a full tuition and fee scholarship for 60 credit hours of full-time study, a nearly cost-free two-year education at Harper College.

The Harper College Educational Foundation provided \$20,000 to the Distinguished Scholar program in 2005 in support of Harper's academically talented student leaders.

Distinguished Scholars must maintain a full-time status at Harper of no less than 12 credit hours each semester and they must maintain a 3.0 grade point average. Additionally, Distinguished Scholars participate in a program of activities designed to enrich their educational experience outside of the classroom.

LaVonya Williams, coordinator and advisor of the Distinguished Scholar program says, "Students develop their leadership skills in highly interactive seminars such as eXcel, a student leadership program on campus. They also are connected to the campus through involvement in student clubs and organizations.

"Off campus, these scholars have volunteered in various organizations, such as homeless shelters, assisted living centers, hospitals and churches. These students benefit academically from this program. They are provided a counselor who assists them with course selection, career and transfer planning and information about scholarship opportunities to ensure a successful transition following their enrollment at Harper." The Distinguished Scholar program is unique because it serves two purposes. It attracts high achieving students in the surrounding high school districts to Harper College and these students give back to Harper College through services and leadership.

Resource for Excellence Grant Highlights

"The eXcel Leadership series allows for highly motivated students to connect with each other, while participating in interactive workshops given by some of the top speakers in our country," said **Michael Nejman**, director of student activities. "Many students have said that the program had a very positive impact on their lives."

The program, however, comes with a significant price tag, Nejman says. "There's the cost of the speaker's fee, airfare, hotel, ground transportation and meals. Even if we supplement the program with local guest speakers, the program requires sufficient funding to maintain its high level of excellence." With the support of a Resource for Excellence grant from the Foundation, Nejman and his staff can plan a program that rivals those at four-year institutions.

"The eXcel Leadership program truly makes a difference in our students' lives," Nejman said. "We think this year's program will be the best yet." ■

New Endowed Scholarship

Philip and Claudette Lobo Displaced Homemakers Endowed Scholarship

Harper College Educational Foundation board member **Dr. Philip Lobo** and his wife, **Claudette**, have established the Philip and Claudette Lobo Displaced Homemakers Endowed Scholarship in support of Harper's Women's Program.

"Displaced homemakers often come to Harper during a difficult transition in their lives. Struggling to support themselves and their children, they seek education to attain employment which pays a self-sufficient wage. Often they have been out of the work force for years—raising their children at home—and now need to upgrade their employment skills. With limited finances, college is not always feasible," said **Kathleen Canfield**, who directs the Women's Program at Harper. "The Philip and Claudette Lobo Scholarship will put the education they need within their reach."

What inspired the Lobo family to create and fund the scholarship? "It has to be very difficult to find the courage and confidence to move on after experiencing an abusive situation and our hearts go out to these women," said Dr. Lobo. "Given the various programs that Harper endorses we feel that anyone who has suffered the setbacks of battery and an abusive relationship and is attempting to pick up the pieces of their lives can use all of the help and support that they can get." The Lobos hope the scholarship fund will continue to grow with the support of other private donors. "It is our hope that this scholarship will increase the level of awareness of how common a problem domestic violence is, while serving as a reminder that these women are not alone."

Canfield and her colleagues see great potential in the support of the Lobos and other private donors who believe in the Women's Program at Harper. "We appreciate the generosity of Dr. and Mrs. Lobo in providing a Harper scholarship for displaced homemakers. And with 8,505 female householders in Harper's district who have children under the age of 18 and no husband present, we would certainly encourage other generous donors to follow Dr. and Mrs. Lobo's lead," Canfield said. ■

The Educational Foundation bids farewell to four members of its board who retired after three consecutive terms of service. Martha Bell, Dick Guttman, Tom MacCarthy and Don Torisky have served Harper College for 52 years combined. We wish to express deep appreciation and gratitude for the distinguished stewardship and outstanding service of Martha, Dick, Tom and Don.

Martha Bell started her volunteer life at Harper in 1991. She spent many years as president of the board, where she elevated and strengthened the professional infrastructure of the Harper College Educational Foundation. Bell was active on many Foundation committees and guided the Art Committee for many years. Bell's active participation and dedication to Harper and her devotion to build the art collection on campus has resulted in a collection that is the largest in the Northwest suburbs.

Dick Guttman, who began his volunteer service at Harper in 1994, is a recipient of the James J. McGrath Award. Guttman was instrumental in creating a supportive, vital partnership between Harper College and Square D, which engendered an engineering scholarship and the growth of Women Make History Month while heralding the company's good name throughout the College.

Tom MacCarthy, who is active in many community organizations and has won the Sears Distinguished Leader Award and James J. McGrath Award, was recognized by Dr. Robert Breuder and Catherine Brod for his "exemplary leadership." MacCarthy began volunteering at Harper in 1993. McGrath Award in 1996 because of his excellent community service with institutions such as Northwest Community Healthcare and the Northwest Cultural Council. Torisky's legacy of major gift fundraising has raised the bar for all levels of fundraising at Harper and demonstrated the power of giving. ■

Retiring Board of Trustees

Kris Howard Jensen and Richard Kolze have 36 years of service on the Harper Board of Trustees between them. Stories from their collective network of friends, colleagues and institutional memories could fill several volumes of a book. Both Jensen and Kolze accepted honorary awards at their final board meeting in April and attended a special farewell reception earlier in the month.

Both Jensen and Kolze will remain involved on campus through their generous stewardship of the endowed scholarships they created: the Dr. Ernest B. and Mrs. D. Kris Howard Endowment for Community Service Scholarship and the Timothy A. Kolze Memorial Endowment Scholarship.

Jensen and Kolze recently shared reflections on their Harper College years with friends and colleagues.

"I enjoyed my work with Harper College," said Richard Kolze. "I always think of Harper as a special resource in the community that offers wonderful, life changing experiences to students of all ages including single moms, kids, adults re-entering the work force and people who need a second chance at an education."

Kolze and his wife established the Timothy A. Kolze Memorial Scholarship in memory of their son who was killed in a car accident. Their \$25,000 gift endowed the scholarship, which "memorializes and honors Tim, who loved to work with his hands." The fund benefits students who are enrolled in vocational courses at Harper.

Jensen started her volunteer work at Harper College when the campus was more pasture and prairie grass than classrooms and labs. "I think the biggest change over the 24 years was watching the College evolve from a two-year institution, which primarily provided academic courses leading to an associate degree and transfer to a four-year institution, into a truly comprehensive community college," Jensen said. Jensen created a scholarship fund in memory of her late husband, Dr. Ernest B. Howard. "The Ernest B. and Kris Howard Endowed Scholarship for Community Service was established as a memorial to my late husband at the time of his death in 1993. The idea of those who established it was to give the scholarship to students involved in the leadership or honors programs that require community service," said Jensen who continues to contribute to the fund.

In looking to the future, I hope the College will continue to be innovative in addressing the changing needs of a diverse population and an evolving world economy. Tradition should always be honored, but it should not become a straight jacket.
