

# President's Message

The Board of Trustees here at Harper is an active and professional group of community leaders whose influence extends far beyond the campus. I want to use this column to better acquaint all of you with our Board and to illustrate how they carry the message of the College to the communities in our district, and to the state and the nation.

Barbara Barton of Palatine joined the Harper Board in 1985 and has served as Board chair. She now serves on the budget review committee and is a member of Friends of Harper. As past president of the Illinois Community College Trustees Association, she served on the public relations, Excellence in Education, federal relations and state relations committees and has served on the governance and bylaws committee for the Association of Community College Trustees. She also serves as president of the Prairie Center for the Arts and is a charter member of the Women's Alumni Group of the University of Southern California. Barbara is also active in the League of Women Voters and the American Association of University Women. She is retired from her position as division sales manager of Avon Products, Inc.

Sarah Born of Arlington Heights is serving her first term on the Harper. Board, where she is active on the budget review committee. She is the current Board liaison to the Illinois Community College Trustees Association. In addition, she has served as president of United Way of Arlington Heights and Friends of Harper, where she now serves on the board. Sarah is also active in the Arlington Heights Youth Commission,

having served as its chair, and on the Arlington Heights Environmental Commission and Illinois Prairie Girl Scout Council. She is the owner of Sales by Sarah, an estate sale business.

John Coste of Schaumburg joined the Harper Board in 1983 and now serves on the budget review committee. The former village manager for the City of Schaumburg, John has also been a generous contributor to and valued supporter of the Harper College Educational Foundation.

Kris Howard of Barrington has been a member of the Harper Board since 1981, having served as its chair for six years. She has served on both the budget and benefits review committees and is also a founding member of Friends of Harper. Professionally, Kris is director of marketing and community affairs at the Suburban Bank of Palatine and also served as the executive director of the Golden Corridor economic development council. She currently serves on the board of directors of the United Way/ Crusade of Mercy for the metropolitan Chicago area and chairs the steering committee of Northwest 2001, a volunteer group that addresses regional issues. A former chairman of the board at Northwest Community Hospital, Kris currently serves as chair of its community services committee and on its finance and medical affairs committees. A former Girl Scout leader and community chair, she also served as the organization's council president and spent nine years on the National Board of Girl Scouts of the USA. She has also been active with PEO, Bridge Youth Services, Resource Center for the Elderly and Infant



Welfare. She was instrumental in the establishment of Harper's annual Women's History Week observance.

Richard Kolze of Palatine, elected last fall, is the newest member of the Harper Board. Having served as superintendent of High School District 211 for 22 years, Dick is now an associate with Hazard, Young and Associates, Ltd., a firm that assists school districts in locating and hiring superintendents. A former member of the Harper Educational Foundation, he has also been active in Prairie Center for the Arts, Resource Center for the Elderly, United Way/Crusade of Mercy, the Private Industry Council and Rotary International.

Larry Moats of Inverness began serving on the Harper Board in 1969 as the student trustee. He was first elected to the Board from 1972-1975 and began his present tenure in 1987. During this time, he has served as the Board's vice chair and secretary and has chaired the budget, negotiations, procedures and cost effectiveness committees, and he currently chairs the technology oversight committee. Larry has served Friends of Harper as director, president and chair of the group's 15-year anniversary committee. On a community level, he is active with youth sports, Indian Guides and Princesses, the Chamber of Commerce and has served as a board member of the Northwest

## Focus On Health Service

The day starts early for the staff in Harper's Health Service. Patients often arrive before the office opens, seeking advice on concerns from headaches, colds and allergies to orthopedic injuries, sexually transmitted diseases and substance abuse.

"We really see a broad range of health concerns," says Becky Santeler, College nurse, noting that patients vary in age, ethnicity, economic status and personal health care philosophies. She adds that at any moment the staff may be summoned across campus to treat broken bones; asthma, anxiety or heart attacks; accidents; or falls.

"We don't just give aspirin and bandaids!" stresses Rosemary Murray, the Service's director. "The Health Service is a crisis center. We assess the problem and determine what the next stage of care should be," she adds. Sometimes patients are treated and released-or they may be seen by the doctors who are available in the Health Service on an appointment basis. At other times, they are referred to specialists or other medical facilities for more intensive medical care.

More and more often the staff sees patients with emotional crises—ill parents, depression, relationship problems or acute anxiety. "We refer these patients to the counseling staff here on campus," Murray says.

The goal of the Health Service is to provide medical services that will help retain students and ensure them a successful college experience. In addition to treating health concerns, therefore, the staff is also committed to providing education and training in physical, emotional, intellectual, social, occupational and spiritual wellness.

Throughout the year the Health Service staff plans seminars and displays on various wellness topics. Next month's Wellness Week observance is an example of this type of programming. On April 12-14, experts will be on campus to address such topics as nutrition, addictions, menopause, relationships, stress, self-esteem and fitness. All Harper employees are encouraged to attend these events. Look for a schedule of events in the Bulletin Board. For additional information, contact Mary Polniaszek at extension 6268.
