

Look at the Changes in Building F!



The Tutoring Center, formerly located on the first level of Building F, is now relocated to the third floor. It's quieter! And more spacious! A separate room is now available for group tutoring, and one-on-one tutoring stations are set up in the more private back area.

This spring we are embarking on a major gifts campaign under the leadership and direction of our Educational Foundation. Last year we contracted with Clements & Associates, a professional fundraising organization, to conduct a feasibility study to determine the likelihood of success for this campaign. Representatives from the organization felt strongly that the campaign would succeed with "Courage, determination, hard work and a commitment to excellence..." We have never set our sights this high before, but we feel confident that with the support of the entire community we can reach high! Many of you have expressed interest and have requested more information about the campaign. This month, we have asked Barb Knoff, assistant director of Development and campaign manager, to answer some questions.

Is this campaign going to be significantly different from our annual campaign?

No! In fact, it will be quite similar. Let me tell you about some variations. First of all, the length of the campaign will be extended from one month to several months so that we can improve the communication that we have with each Harper employee. Because it's important for each employee to be familiar with the Foundation-and how its funds are directed—our volunteers will contact each faculty and staff member to be certain that he or she truly understands the impact that each contribution makes. As in the past, every \$26 contribution will qualify for the raffle, and we expect to have wonderful prizes again this year! Another

change from the annual campaign of the past few years involves our multiyear pledges. Because we need to think of the campaign as a long-term effort, our multi-year pledges will be especially important in assuring longterm success.

Are the four identified areas of need the only areas to which faculty and staff can contribute?

The feasibility study has identified four areas of need that will be addressed during the campaign. These include new technologies, excellence in teaching and learning, scholarship endowment and funding for an art gallery. However, the Harper College Educational Foundation has more than **100 funds** and, as before, an employee can earmark the donation to any of these funds or to a pet project, area of concern or fund that especially appeals to him or her.

Is it true that a dollar goal for the campaign has already been set?

No. Recommendations were made as a result of the feasibility study conducted by Clements & Associates, but the actual goal will not be set until after the employee and board campaigns have been completed. In addition, we expect additional gifts during the time frame of the campaign that will also determine the level of support that we can expect. The greatest indicator of the success of the major gifts campaign, however, will be the strength of the employee and board campaigns.



Tell us more about the theme of the major gifts campaign.

The theme for the major gifts campaign is Harper College: More Than You Ever Thought...Possible! We'll expect to have a subtheme for the annual campaign, however, which we'll use for our activities, contests and other promotions. We'll have lots of fun with this!

As I have noted in other issues of the "Insider," the success of the major gifts campaign clearly will require our collaborative effort. Whatever you can offer-whether it be contributing financially, suggesting potential donors or contacting community groups to deliver our message-we hope to hear from you. Please feel free to contact Barb Knoff, Felice Avila or me if you have additional questions. Our combined efforts will bring Harper closer to realization of the Preferred Future statement, "To expand and aggressively develop public and private funding sources in order to achieve the vision of the College."

The whole is equal to the sum of its parts is a maxim that well describes Workforce and Professional Development, one of Harper's newest organizational units. UNIX, Corporate Services, Manufacturing, Business and Professional Development and Workforce ESL and Basic Skills fall under the umbrella of this unit.

Spearheaded by Ed Dolan, vice president of Academic Affairs, the unit was established to meet state and federal initiatives on workforce development.

Sheila Quirk, assistant to the vice president of Academic Affairs for Workforce and Vocational Development, states, "All workforcerelated programs were pulled together and refocused with the purpose of fulfilling the training needs for corporate employees. We do a needs analysis and fill these gaps either through customized training, specific continuing education classes or educational support services. To make attendance easier for the employee, we offer classes both on campus and on-site."

Corporate Services, staffed by Lori Cronin, Bob Butts, Marlene Bernstein and Pat Turner, is two-fold in its operations. Cronin notes: "Both Bob and I sell the program to corporations and subsequently tailor or customize training to meet specific corporate needs. This is possible only because of the expertise offered by other members of the College."

Mel Hampton offers training in computer operating systems, such as UNIX, C Programming and Novell.

Pat Coleman offers assistance to manufacturing companies through training in ISO 9000 (to prepare for certification) and classes in electronics, plastics, EPA regulations and quality control. Bonnie Kurth supports both Pat and Mel in their programs.

The department's business and professional development offerings are coordinated by Linda Soto, whose training programs run the gamut from classes for the novice entrepreneur to classes in international business. Her support staff includes Halina Polakowski and Mary Lanus.

Barb Hooper and Kate Duffy staff the Workforce ESL (Workforce Instruction Program) and Basic Skills Program. They provide training in a variety of subject areas including basic reading, writing, mathematics and nonnative literacy. "With forecasters predicting that 70 percent of the workforce will require training beyond high school, the need for this unit seems decided," says Quirk. "There will be a constant need for re-education to keep up with the times. It's up to us to provide that re-education by keeping classes in step with current market demands."

Quirk's energy and obvious enthusiasm are contagious. "I wear two hats," she says, "You know—one for professional development and one that refers to the word vocational in my title. However, I'll have to explain that in another article!"

Quirk is genuinely responsive to requests for information or for ideas that contribute to the success of the program. She can be reached at extension 6668.

Insider's View of Linda Alberts Frank

Change has been a big part of Linda Alberts Frank's life. She started working at Harper 14 years ago as a clerk in the Admissions Office. Soon after, she accepted a position in Student Development, and 10 years ago she landed her present job as Harper's testing specialist. But even those 10 years have seen change. "When I first started, I was the only full-time person in the office," she says, adding that the office is now staffed by three full-time and five parttime employees.

"The whole focus of the testing area is changing," she says. "It's very interesting and challenging. Where we once administered tests to students who used a pen or pencil, we are now moving toward interactive computer testing." She notes that the center now administers 20,000 tests annually and is open six days (and four evenings) each week. Some of the tests include exams for students taking telecourses, GED and ACT exams, certification exams, credit by examination and assessment tests for placement in Harper courses.

But the change in Linda's life extends beyond the campus, too. In the last few years she has remarried, earned a master's degree in counseling and guidance from Northeastern and has taken up some hobbies that were on hold as she worked toward the degree. She also has become a grandmother, and the merging of two families results in plenty of activity.

"We're real busy!" she says.
