HARPER'S 17¢ TAX REFERENDUM DEFEATED 2 TO 1

Voters in Harper College district #512 rejected, by a two to one margin, two tax increases requested in a March 21 referendum seeking an eleven cent hike in the education fund and a six cent hike in the building (maintenance) fund rates. A total of 6,240 voters from Elk Grove, Palatine, Schaumburg and Wheeling townships and Barrington High School District #224 defeated the much needed tax boost by approximately 67 per cent. The education fund proposition was defeated by a 4,180 to 2,031 vote and the building (maintenance) fund by a 4,215 to 1,997 vote. Four precincts out of 43 approved both issues.

The tax increase sought by the College is needed to cover expanding maintenance costs, increased enrollment, and a loss of approximately \$800,000.00 in chargeback revenues from other districts.

Commenting on the loss of the referendum, Harper Board member James J. Hamill pointed out that high taxes and inflation were responsible. In a statement issued to the press following the election, Harper's president, Dr. Robert E. Lahti, said "We remain confident that some future date will result in a more positive response to the higher educational needs of the northwest suburban community."

Just when the College will try again has not yet been determined, but the district will have to wait at least 60 days for another attempt at referendum passage.

HARPER BOARD ELECTION TO BE HELD SAT., APR. 11

Six candidates, including two incumbents, are running for two positions on the Board of Trustees of Harper College in an election to be held on Saturday, April 11. Seeking office are three women and three men.

Running for a third term on the Board is incumbent Mrs. Jessalyn M. Nicklas, Palatine housewife, who has been actively associated with the community college movement since 1961. A graduate of Northwestern University in business administration, Mrs. Nicklas has been involved in community affairs since that time. She was a member of the Northern Cook County Committee established to study the feasibility of establishing a college in the northern suburbs. She has also been active in the statewide junior college field, having helped set the pattern of operation for the Illinois Association of Community and Junior Colleges (IACJC), and served as first president of its trustees' division. Mrs. Nicklas was elected to the first Board of Trustees of Harper College in 1965 for a two-year term, and was reelected to a three year term in 1967.

Also seeking reelection is incumbent Dr. LeRoi Hutchings, resident of Mt. Prospect and a chemical engineer who is involved in engineering research and development for Universal Oil Products in Des Plaines. Dr. Hutchings received his Ph.D. degree from Northwestern University. He was appointed to fill a vacancy on the Harper Board in 1967 and was elected to a two-year term in 1968. father of two teen-age daughters, Dr. Hutchings' wife Mary Jo is librarian for the Mt. Prospect Public Library. He is a member of Phi Lamda Epsilon, national honor chemical society, and a member of Sigma Xi, research honorary.

Others seeking office include two candidates running on the same platform, Dr. Joseph C. Morton of Arlington Heights and Mrs. Hannah K. Wilson of Mt. Prospect. Dr. Morton, associate professor of American History at Northeastern Illinois State College, did his undergraduate and graduate work at the University of Maryland, College Park. He is a veteran of

four years in the United States Air Force, and for the past ten years has been involved in college teaching. Prior to his current post, he taught at the University of Maryland at Montgomery Junior College, Tacoma Park, Maryland, and at Waynesburg College, Waynesburg, Pa. He is an elder at Southminster United Presbyterian Church. Dr. Morton is married and the father of four children ages five to 14.

Mrs. Hannah K. Wilson, the fourth candidate to file for the election, is a naturalized citizen of the United States and a native of Saskatchewan, Canada. She received her B.S. degree at Marquette University, Milwaukee and did graduate work at Loyola University in Chicago. She taught at Marquette, and during World War II served in the Army Nurse Corps. She was director of school health services in District 57 for ll years and teacher-nurse consultant at New Trier Township High School in Winnetka from 1965 to 1969. She is active in the Northwest Chapter of the Council of Exceptional Children and is a member of the executive board of the Mt. Prospect Education Association. She has been a Mt. Prospect resident for 21 years.

A certified public accountant and attorney, Richard J. Durava of Arlington Heights, was the fifth candidate to file. Durava, trust officer for the Northern Trust Co., Chicago, received his undergraduate degree from DePaul University, did his CPA work at the University of Illinois, and obtained his law degree from DePaul. He had 15 years of auditing experience prior to joining the Northern Trust Company. Durava is a member of the Arlington Heights Plan Commission, a member of the Northwest Suburban Shrine Club and the Chicago Medina Temple. He has lived in Arlington Heights for three years.

Mrs. Jane Lea Toot, Arlington Heights housewife and physical therapist, is the sixth candidate for the Board election. Mrs. Toot attended Grand Rapids Junior College before receiving her degree at the University of Michigan. She is a past president of the local chapter of the American Association of University Women (AAUW) which office she held for two different terms. In 1965, Mrs. Toot was Harper's referendum chairman and was chairman of the 1970 citizens' committee working for Harper's March 21 referendum. She has lived in Arlington Heights for the past ten years, is married and the mother of two children.

HARPER DEDICATION CEREMONIES SCHEDULED FOR MAY 3, 1970.

According to Dr. John H. Upton, Harper's Dedication Committee chairman and director of governmental relations for the College. plans for the College Dedication are being formalized at the present time.
