

Early College Concurrent Enrollment Supplemental Form High School Student

Criteria:

- Be at least 16 years old OR Junior or Senior Status.
- A minimum grade point average of 3.0 (or 4.0 on a 5.0 scale) is highly recommended.

Steps for Approval:

1. Complete the Harper Early College Concurrent Student Application for Admission - version in C-103 or online at www.harpercollege.edu/apply.
Note: there is a \$25 one-time, non-refundable application fee.

2. Submit the following to:

3. Complete placement testing (if needed). College level placement into English and/or math is typically required.
4. Review academic history and college readiness with an Advisor or Counselor from the Center for New Students and Orientation.
5. Once steps are completed, student will be contacted regarding approval decision.

This process may take approximately two weeks to complete.
